

- ✓ **C** – Payments will be split with **first payment of N5,000 on July 31st, N5,000 on August 31st and the other N5,000 on October 31st.**
- ✓ **D** – Payments will be split with **first payment of N5,000 on July 31st, N10,000 on August 31st and the other N15,000 on October 31st.**
- ✓ **E** – Payments will be split with first payment of **N15,000 on July 31st, N10,000 on August 31st and the other N15,000 on October 31st.**
- ✓ **Investors** – Monthly payment of **various sums ranging from N5,000 to N10,000 monthly.**
- **CAR AWARDS:** The Company will proceed with Award of Cars to Eligible Users who has met the required condition.
- **ADVERTISERS / PARTNERS:** The Company has proceeded with a strong campaign to get more advertisements on the Platform.
- **PAYMENT METHODS:** The Company has partnered with a 3rd Party Financial Institution to ensure easy, effective and efficient flow of user payouts. The payment method will be implemented from 13th of June, 2020.
- **THE PLATFORM AND MEMBERSHIP:** The platform is once again ready for users to commence activities. However, the Account Section has been reset and users are meant to register afresh to have access to the platform. It is also important to note that this does not affect eligible users due for payout.
- **YOURMMY FOODS RESTAURANT:** The Company is set to invest in acquiring a food restaurant. Yourmmy Foods (the restaurant) will be a sole property of Yourtimepays Integrated Services Limited, with proceeds from the restaurant duly used for Users of the platform, Investors and Partners.

The funds generated from sales will be used to develop the overall platform and all our Users will get a 20% Discount for each meal purchased; this discount last forever. The Platform has already developed an online food ordering and delivery platform that has been operational since 26th of May, 2020.

The launch of Yourmmy Foods Restaurant on the 4th of July, 2020 is the beginning of an investment expansion project for the Company as we are set to open the Business in 28 major cities in Nigeria.

- **FACE OF THE COMPANY:** The Company will appoint an Ambassador to be the Face of the Company, to represent and sell the Company to prospective stakeholders. The Appointment will be done based on the discretion of the Company.



- **4TH YEAR ANNIVERSARY CELEBRATION:** The Company will hold a ceremonial fourth year Anniversary to be attended by all stakeholders. The Event will highlight the overall progress of the Scheme and will aim to unite all stakeholders while proscribing advanced modules towards sustainability, growth and effective operation of the scheme.


- The Independent Corrupt Practices and Related Offences Commission (ICPC).
